San Diego Rapid Response Network Line (SDRRN)

- Phone Number: (619) 536-0823 / Call this number to report immigrant detentions and to request immigration legal assistance. Due to high call volumes, the Network may not be able answer your call right away but leave a message with your name and phone number and you will be called back as soon as possible.
- Operating Hours: Monday–Thursday from 8:30am–5:00pm and Fridays from 8:30am–4:00pm

Programa de Defensa Legal de los Derechos de los Inmigrantes del Condado de San Diego (IRLDP)

- Contact: (619) 446-2883
 - For individuals detained at Otay Mesa Detention Center in San Diego they can dial: 1157#. This number is free to dial, and the individual will not be charged for this call.
- When to call: If a loved one is detained and in deportation proceedings or a loved one is in alternative to detention status and has ties to San Diego County. This program seeks to connect individuals in deportation proceedings to a free attorney.
- What information to have ready: For individuals calling the IRLDP number, be prepared to provide name, date of birth, detention A#, expected immigrant defense issue (i.e. asylum, criminal conviction removal, suspension of deportation, etc), and other information regarding your case.
